#### Purchase and Use of Aerial Photographs in connection with the Residential Properties (First-hand Sales) Ordinance (Cap. 621)

1. This Practice Note provides guidelines to users on how to purchase aerial photographs from the Survey and Mapping Office (SMO) of the Lands Department in connection with the Residential Properties (First-hand Sales) Ordinance, Cap. 621 ("the Ordinance"), and the uses of such aerial photographs.

#### Provisions of the Ordinance Relating to the Use of Aerial Photographs

- 2. Under section 19(2)(g) of the Ordinance, an aerial photograph of the development must be set out in the sales brochure of the development. The updateness, scale and extent of coverage are further stipulated in sections 7(2) and 7(3) of Schedule 1 to the Ordinance as below:-
  - ➤ Under section 7(2) of Schedule 1 to the Ordinance, "the aerial photograph of the development must be the latest one as at the date on which the sales brochure is printed, as taken by the Survey and Mapping Office of the Lands Department at a flying height below 7000 feet".
  - ➤ Under section 7(3) of Schedule 1 to the Ordinance, "the aerial photograph of the development must be at least 16 centimetres in length and 16 centimetres in width and must show the development and the surrounding area within 250 metres from the boundary of the development".
- 3. Under section 48(1) of the Ordinance, the aerial photograph of the development must be made available for inspection at the place where the sale is to take place and under section 48(2) of the Ordinance, the aerial photograph to be displayed must be at a scale within the range of 1:700 to 1:800.
- 4. Under section 49 of the Ordinance, the aerial photograph of the development must be made available for inspection on the website designated by the vendor of the residential development (the "Website").

#### Search of Aerial Photographs Suitable for Use

5. Representative of the vendor of the residential development ("the Vendor's Representative") may search the aerial photographs through the Hong Kong Map Service 2.0 ("the HKMS 2.0") (<a href="https://www.hkmapservice.gov.hk">https://www.hkmapservice.gov.hk</a>) or at the Map Publications Centre, Hong Kong ("the MPC/HK") (address: 6/F, North Point Government Offices, 333 Java Road, North Point, Hong Kong, tel.: 2231 3187, fax: 2116 0774, email: <a href="mailto:smosale1@landsd.gov.hk">smosale1@landsd.gov.hk</a>, opening hours: Monday to Friday 9:00am to 5:30pm, excluding public holidays).

## Order Methods, Payment and the Undertaking on the Conditions of Use of the Aerial Photographs

- 6. The Vendor's Representative should delineate "the area which covers the development and the surrounding area within 250 metres from the boundary of the development" ("the Development and Surrounding Area") based on the approximate scale of the aerial photograph for ordering: (i) the hard copy of the portion enlargement of the aerial photograph at scale 1:700 to 1:800 for display at the sales office of the development; and (ii) the digital file of the above aerial photograph for preparing the sales brochure 1 and for viewing at the website 2 of the development.
- 7. The Vendor's Representative should place the order either through the HKMS 2.0 or submitting a completed Order Form (See **Appendix A**) together with a duly signed "Undertaking for Use of Aerial Photographs from the Survey and Mapping Office, Lands Department in connection with the Residential Properties (First-hand Sales) Ordinance (Cap. 621)" ("the Undertaking") (See **Appendix B**) in person to the MPC/HK.
- 8. For order through the HKMS 2.0, the Vendor's Representative should read and agree to abide by the conditions of use in the Undertaking before placing the order. The Vendor's Representative shall submit the duly signed Undertaking to the MPC/HK at the time of or before collecting the products.
- 9. The Vendor shall only use the aerial photographs for the purposes specified in the Ordinance. No other usage is permitted. The Undertaking also deals with the Hong Kong Special Administrative Region (HKSAR) Government's intellectual property rights subsisting in the aerial photographs.

10. Payment can be settled in person at MPC/HK or through HKMS 2.0 at the time of ordering. The payment methods are listed below:-

Payment through HKMS 2.0:

- Credit card
- PPS
- Mobile payment methods (e.g. FPS, Alipay, WeChat Pay, etc.)

#### Payment at MPC/HK:

- Cash
- Cheque (crossed cheque payable to "The Government of the HKSAR")
- Electronic payment methods (e.g. Octopus Card, credit card, Alipay, WeChat Pay, etc.)
- 11. The ordered products will be ready for collection five working days after the payment has been settled. The Vendor's Representative should collect them in person at the MPC/HK.

"Survey and Mapping Office, Lands Department, The Government of HKSAR

7. The Vendor shall inform the Survey and Mapping Office of the Lands Department the link to the website on which the aerial photograph and sales brochure will be made available for inspection.
